1. CALL TO ORDER

The meeting was called to order by Chair Sternquist at 7:48 a.m.

2. **PLEDGE OF ALLEGIANCE**

The Pledge of Allegiance was led by Member Vizcarra.

3. ROLL CALL

4. CONFIRMATION OF AGENDA BY CHAIR AND CHIEF EXECUTIVE OFFICER

After discussion, by Common Consent, the Chair and Chief Executive Officer confirmed the agenda as presented.

5. **REMARKS BY CONGRESSWOMAN LINDA SÁNCHEZ**

Member Cory Moss introduced Congresswoman Linda Sánchez and thanked her for attending. Congresswoman Sánchez congratulated Foothill Transit on



its \$50 million grant and stated that she hopes the assistance will help increase ridership. She also reported on how the infrastructure bill will help improve public transportation. She also stated that she looks forward to working with the cities in the San Gabriel Valley in ensuring they get their fair share of funding. She thanked the Governing Board for allowing her to speak at the meeting.

6. **REVIEW & APPROVAL OF THE MINUTES**

Approval of the minutes for the Governing Board Meeting of January 28, 2022.

Motion by Vice Chair Calaycay, second by Member Shevlin, the minutes for the Regular Meeting of January 28, 2022 were approved. Motion carried 18-0. Member Diaz abstained.

7. INTRODUCTION OF FOOTHILL TRANSIT BUSINESS PARTNERS

Laura Hendricks, Chief Executive Officer, Transdev U.S., addressed the Governing Board. Ms. Hendricks thanked the Governing Board for their support and assured the board that Transdev is committed to the safety and security of their team.

Andres De Los Rios, Keolis General Manager, Foothill Transit Operations, addressed the Governing Board. He reported that the Pomona Facility has not had any COVID cases since mid-February. He thanked Member Preciado and Doran Barnes, Chief Executive Officer, for introducing Keolis staff to a number of organizations that have assisted in the hiring of new Keolis employees.

8. GENERAL PUBLIC COMMENT

Jaime Villanueva, Teamsters Local 572, addressed the Governing Board. He stated that Teamsters Local 572 represents the mechanics at the Arcadia facility. He expressed the union's support for Transdev, and stated that of the various contractors that have operated the services at Arcadia, Transdev has been the only contractor to provide the tools needed by mechanics that allow them to keep the buses running.

Dickie Rodriguez, Transdev Technician, addressed the Governing Board. He stated he is representing the mechanics and shared that Transdev provides the special tools to keep the buses running and that Transdev's upper management visits the facility and they show their appreciation for staff.



8.1. Chief Executive Officer Response to Public Comment

There was no response to Public Comment by the Chief Executive Officer.

9. FOOTHILL TRANSIT SECURITY UPDATE

Recommendation: Receive and file an update on Foothill Transit's Security efforts.

John Curley, Chief of Safety and Security, presented this item.

Mr. Curley reported that there has not been a bus operator assault since November 2021. Bus operator assaults has been added to the PTASP as something that needs to be mitigated. He reviewed the Security and Emergency Preparedness Plan (SEPP), and the development of a Foothill Transit Emergency Operations Center. He also reported on workplace and intervention training, Foothill Transit Watch safety mobile app, and additional security goals.

Mr. Curley introduced Shawn Kehoe, Captain, L.A. County Sheriff, who provided an update on the services that the Sheriff's department provide the region. He gave an overview of the Sheriff's transit mental evaluation team and the work they do with persons experiencing homelessness. He also reported on the Sheriff's bus riding teams and the mitigation of fare evasion.

Mr. Curley responded to questions and comments by the Governing Board. There was no Public Comment on this item.

The Governing Board received and filed this presentation.

10. COVID-19 OPERATIONS UPDATE

Recommendation: Receive and file an update on the continuing impacts of COVID-19 on Foothill Transit's operations.

LaShawn King Gillespie, Director of Operations and Customer Service, presented this item.

Ms. Gillespie reported that the TSA has extended the mask mandate through April 18, 2022. The marketing and communications team continues to communicate the mandate to Foothill Transit customers. She also reported



on the operational challenges and the decrease of COVID related absences at the contractors. Staff is also tracking when the contractors has adequate staff and how much additional service is being provided. The contractors are providing onsite testing for their employees. The vaccination rate for the Foothill Transit team is tracking at more than 75 percent.

Member Shevlin asked if there is resistance by riders in regards to wearing masks on buses. Ms. Gillespie responded that there is resistance and that is why a strong communications message has been maintained and staff continues to work closely with the contractors. There was no Public Comment on this item.

The Governing Board received and filed this presentation.

11. CLUSTER 5 ELECTIONS NOTIFICATION

Recommendation: Receive notification of Cluster 5 elections to be held on May 27, 2022.

Christina Lopez, Board Secretary, presented this item.

Ms. Lopez reported that Cluster 5 consisting of three county appointees will hold elections for Executive Board Member and Executive Board Alternate at the May 27, 2022 Annual Meeting. The current representatives on the Executive Board are Executive Board Chair Cynthia Sternquist and Executive Board Alternate Sam Pedroza.

She reviewed the process for those that may be interested in completing a Notification of Interest Form. The form is optional, and used as a way to inform other members of their cluster of their interest on serving on the Executive Board. Governing Boards Members elected to the Executive Board will serve a term that runs from May 2022 to May 2025.

There were no questions or comments by members of the Governing Board and there was no Public Comment on this item.

The Governing Board received notification of the Cluster 5 elections.

12. FISCAL YEAR 2022 BUSINESS PLAN INITIATIVES UPDATE

Recommendation: Receive and file an update on Foothill Transit's FY2022 Business Plan Initiatives.



Kevin Parks McDonald, Deputy Chief Executive Officer, presented this item.

Mr. McDonald provided an update on the nine agency initiatives that are included in the current business plan. The nine initiative are as follows: Fuel Cell Bus and Infrastructure Project, Zero-Emissions Double Deck Bus Project, Facility Security Hardening, Foothill Transit FORWARD, Mt. SAC Transit Center, Cal Poly Pomona Bronco Mobility Hub and Class Pass, Operations Contract Procurement, Legislative Advocacy, and ExpressLanes Operation.

Member Williams asked that fuel diversity be tracked; the new, future and what the agency is required to have. There was no Public Comment on this item.

The Governing Board received and filed this presentation.

13. FISCAL YEAR 2022 BUDGET UPDATE

Recommendation: Receive and file the February year-to-date budget update for the fiscal year ending June 30, 2022.

Michelle Lopes Caldwell, Director of Finance and Treasurer, presented this item.

Ms. Caldwell reported on the budget results through February 28. For the fiscal year that ends on June 30, 2022. The budget is within the approved year-to-date budget of \$73.9 million. Foothill Transit continues to incur expenses related to COVID-19 and they amount to approximately \$473k through February. Foothill Transit through February is currently \$4.4 million under budget. The Purchased Transportation account experienced the greatest amount of savings at \$3.4 million. The cost of fuel is approximately \$1 million over the year-to-date CNG fuel budget. It is anticipated the CNG fuel budget will end the fiscal year \$1.5 million over budget. Staff is still forecasting to finish the year within the approved operating budget.

The pandemic has continued to impact service, as lower ridership has been experienced throughout the region. To mitigate the fare revenue decrease a successful Summer Sale was held. Through February, \$4.7 million of fare revenue has been collected. In addition, Foothill Transit has drawn down all \$30 million of CRRSA funds.

Member Barakat asked that staff follow-up with the Sanitation District, which is processing food waste for renewable fuel. There was no Public Comment on this item. Statement of Proceedings

Comments by Mr. Doran J. Barnes, Chief Executive Officer, Foothill Transit.


Mr. Barnes reported the following:

- The \$50 million grant Foothill Transit received are specifically designed to maintain essential services and maintain workforce.
- Foothill Transit received a \$7.9 million from the Bus and Bus Facility Program that will assist in expanding the Double Deck Bus Program.
- On Wednesday, Foothill Transit lowered fares on express routes and Silver Streak to the local amount \$1.75.

- Foothill Transit will be having its picnic at the L.A. County Fair on May 21, 2022. More information will be provided to Governing Board Members.

Federal Update:

FY 2022 Appropriations Bill

Last month, on March 15, 2022, President Biden signed the \$1.5 trillion Fiscal Year (FY) 2022 omnibus appropriations bill after it passed the House on March 9, 2022, and the Senate on March 10, 2022. This omnibus bill funds federal government agencies for the remainder of FY 2022, through September 30, 2022. Congress had to complete this appropriations package and the President had to sign the bill by March 15, 2022, when the final FY 2022 continuing resolution (CR) was set to expire. A four-day CR through March 15, 2022, had been enacted while the omnibus appropriations bill was being developed to allow extra time for Congress to pass the bill and for the President to sign it. Two previous FY 2022 CRs had been extended through March 11, 2022, and February 18, 2022, extending government funding for the balance FY 2022 beyond the original date it was set to expire, on December 3, 2021. The passage of this annual appropriations bill establishes the funding levels for federal programs and grants available to local entities and is in addition to the funding provided to programs under the Bipartisan Infrastructure Law (BIL). The passage of this spending bill also eliminates the threat of any further CRs and avoids the prospect of federal government shutdowns through September 2022.

<u>FY 2023 Budget</u>

On March 28, 2022, President Biden announced his \$5.8 trillion budget proposal for FY 2023. Among the Administration's priorities outlined in the proposed budget is a \$13.6 billion request for public transportation, which reflects a \$607 million increase from the FY 2022 enacted level. Combined with the advance appropriations included in the Infrastructure Investment and Jobs Act (IIJA) (P.L. 117-58), \$21.1 billion has been requested by President Biden for public transit in FY 2023. The President's proposed budget request also includes \$2.85 billion for the Capital Investment Grants (CIG) program. Combined with IIJA funding, the Budget accounts for a total of \$4.5 billion for FY 2023 CIG projects.

FY 2022 Transportation Spending Bill

Congress moved forward again this year with the new earmark system that they re-introduced last year. Both Senate and House members will be requesting funds in most appropriation bills for the FY 2023 Appropriations process, including the transportation spending bill. With support letters from the San Gabriel Valley Council of Governments, San Gabriel Valley Economic Partnership, State Senator Josh Newman, and the Cities of Glendora, Industry, Monrovia, Pasadena, and Temple City, Foothill Transit successfully submitted earmark requests to its congressional delegation for the purchase of 24 zeroemissions double-deck buses. Congressionally directed spending requests were submitted to Senators Padilla and Feinstein and community project funding requests were submitted to U.S. Representatives Chu, Kim, Napolitano, Sanchez, Schiff, and Torres.

Funding Opportunities

On March 4, 2022, the FTA released a Notice of Funding Opportunity (NOFO) for \$1.1 billion in competitive grants under the FY 2022 Low or No Emission Grant Program and \$372 million for the Buses and Bus Facilities Program. The U.S. Department of Transportation also released NOFOs on March 23, 2022 totaling \$2.9 billion in new funding for infrastructure projects through three grant programs that focus on supporting projects that improve safety, economic competitiveness, equity, and climate and sustainability.

We worked closely with the California Transit Association and our congressional delegation leading up to the FTA's release of its NOFO to allow California transit agencies to meet the FTA's new Fleet Transition Plan requirements by submitting their Zero-Emission Bus Rollout Plans that are in place as required by the California Innovative Clean Transit (ICT) regulation. Thanks to this advocacy, the FTA's FAQs for these grants clearly state that a previously prepared or adopted Fleet Transition Plan, such as the ICT Zero-Emission Rollout Plan, meets the requirement of the IIJA and can be included in the grant application to meet program requirements. Consistent with further FTA advocacy that we have worked on with the California Transit Association in the past year, the FTA will rate a zero-emission project higher than other zero-emission projects if the applicant demonstrates that the proposed grant project and fleet transition plan support the conversion of a transit agency's overall fleet to zero-emissions. We are dedicated to continue our engagement with our congressional delegation and community supporters to ensure the maximum benefit for Foothill Transit on these funding opportunities.

Congressional Visit and Briefings

In late February and early March, Foothill Transit participated in virtual congressional briefings with staff from U.S. House Representatives Adam Schiff and Norma Torres' offices, organized by Transportation Energy Partners as part of a two-week summit. The purpose of the briefings was to advance and emphasize the importance of federal programs that support alternative clean fuels and vehicles, including battery-electric and hydrogen fuel cell buses and infrastructure.

In March, we met virtually with Congresswoman Linda Sánchez's staff to talk about Foothill Transit's priorities, and we also hosted Congresswoman Norma Torres and her staff on a tour of our double-deck electric bus, zero-emissions fleet, and maintenance and operations activities at the Pomona Operations and Maintenance Facility. This tour highlighted the kinds of local infrastructure investments that the Bipartisan Infrastructure Law, or the IIJA, will support. The increased funding that the IIJA accounts for is critical to accommodating our zero-emissions requirements, and we are grateful to our congressional delegation for their role in having Congress pass the bill last year.

State and Local Update:

The State Legislature reconvened from Spring Recess on April 18, 2022, and will have until April 29, 2022 for policy committees to hear and report to fiscal committees on fiscal bills introduced in their house. The last day for policy committees to hear and report to the floor non-fiscal bills introduced in their house is May 6, 2022. The Legislature is also expected to continue with budget hearings this spring as part of the budget process.

<u>State Budget</u>

On March 23, 2022, Governor Newsom announced a \$11 billion relief package to aid Californians coping with the impact of record-high fuel costs and inflation by proposing incentives for riding public transit, supporting active transportation projects, and increasing zero-emission vehicle adoption. In addition to providing relief for gas and diesel taxes, his proposed transportation package includes:

• <u>\$750 million to fund three months of free transit for Californians</u> in the form of incentive grants to transit and rail agencies to design fare free or heavily discounted fare programs that can be maintained for three months;

- <u>\$500 million in active transportation projects</u> that promote biking and walking, which further builds on the \$500 million in proposed Active Transportation Program (ATP) funding included within the Governor's proposed FY 2023 State Budget, bringing his proposed ATP funding proposal to \$1 billion;
- <u>\$9 billion in tax refunds</u> in the form of \$400-per-vehicle direct payments to registered vehicle owners, capped at two vehicles;
- <u>\$1.75 billion for zero-emission vehicles and infrastructure</u> to be fasttracked from within the Governor's \$10 billion Zero-Emission Vehicle package

On April 8, the California Department of Finance announced a proposed "trailer bill" that would implement the Newsom Administration's \$750 million three-month fare-free transit proposal mentioned above that would incentivize transit agencies to implement fare-free or heavily discounted transit service. The language of this proposed trailer bill would appropriate \$750 million from the State's General Fund to the California State Transportation Agency to fund grants to transit agencies to implement farefree transit service for three consecutive months, starting no later than 60 days after the trailer bill takes effect. The funding allocation to each transit and rail agency within this proposal is based on their share of the FY 2020 statewide fare revenues and the funding received by each agency is allowed to cover administrative costs, operating expenses, and costs associated with offsetting fare revenue loss.

These recommendations by the Governor and the California Department of Finance still need to be considered by the legislature, and the next State Budget milestone in process is expected in Governor Newsom's May Budget Revision to the FY 2023 State Budget that he released in January. This "May Revise" will be updated to account for the State's actual revenues and comes with a June 15, 2022 deadline to pass the State Budget for the next fiscal year.

State and County Briefings

Foothill Transit continues to meet with the state legislative delegation and quarterly with the transportation staff for LA County supervisors to communicate Foothill Transit's initiatives and progress with its hydrogen fuel cell fleet and infrastructure. In early March, we met with the newly appointed San Gabriel Valley Metro Board Deputy for Metro Board Member Tim Sandoval to discuss regional interests that advance mobility in San Gabriel Valley. In the past few months, we successfully held briefings for members of

our Executive Board with Assemblymembers Lisa Calderon, Phillip Chen, Mike Fong, Freddie Rodriguez, and Blanca Rubio. We also met with transportation staff serving Senators Josh Newman, Anthony Portantino, Susan Rubio, and Assemblymember Chris Holden. Through our engagement, Foothill Transit was also able to receive letters of support from Senator Rubio and Assemblymembers Holden and Rubio for this year's cycle for the Transit and Intercity Rail Capital Program (TIRC) grant application for 24 zero-emissions double-deck buses. We will continue to work closely to keep our state and local delegation consistently informed on the latest status of Foothill Transit programs, initiatives, and concerns to ensure that we derive the maximum benefit for the community and riders that we serve.

Recommendations

At the recommendation of the Executive Board, authorize the Chief Executive Officer to adopt the proposed cancellations of Line 690 and route variant of Line 292 to Foothill Transit's service.

Analysis

At the December 17, 2021, Governing Board meeting, the Board authorized staff to seek public input and conduct a public hearing regarding the proposed cancellations of Line 690 and route variant of Line 292. The goal of the proposed cancellations is to eliminate bus service with poor ridership and reinvest those resources in other Foothill Transit lines with a demonstrated need. A summary of each proposed cancellation follows:

<u>Line 690</u>

Line 690 is a Foothill Transit local line that operates between the cities of Montclair and Glendora during peak hours on weekdays. Line 690 provides 14 westbound trips in the morning and 10 eastbound trips in the afternoon/evening. This line services the cities of Montclair, Claremont, Pomona, La Verne, San Dimas, and Glendora. Key transfer hubs include the Montclair Transit Center, the Claremont Transit Center, and the Lone Hill Park & Ride.

Since the opening of the Foothill Extension of the Metro Gold (now L) Line in March of 2016, ridership on Line 690 has been low, (see Table 1). Over the years, Foothill Transit has made several modifications to Line 690 in hopes of increasing ridership, but ridership remains low (see Table 2). Some of the changes made include reducing the fare to match the local fare structure, changing the terminus from Azusa Intermodal Transit Center to the Citrus L Line Station, as well as adjusting the number of daily trips to attract ridership. Due to the impacts of the COVID-19 pandemic, Line 690 was paused in April and May of 2020, and again beginning in January 2021. Currently, Line 690 is not operational.


Line 690 Budget Impact

The projected annual cost savings associated with this cancellation would be \$438,700.



<u>Line 292</u>

Line 292 is a Foothill Transit local line that operates between the City of Pomona and Claremont during peak and non-peak hours on weekdays. Line 292 provides nine trips in the morning and seven trips in the afternoon/evening. Line 292 contains a two-trip variant that travels on Baseline Road, offering one trip in the morning and one trip in the afternoon.



We have monitored the route variant for Line 292 since January 2021, and ridership on that variant has been minimal (see Table 3). On average, there are 20 weekdays every month. The route variant is currently averaging significantly less than one boarding per weekday. This is true for both the northbound and southbound trips.

Public Meetings and Results of Public Comments

The formal public comment period began on January 1, 2022, and concluded on March 1, 2022. To encourage public comments, Foothill Transit staff conducted two virtual public workshops on two separate days in both the afternoon and in the evening. A public hearing was held virtually on February 15, 2022, at 5:30 PM to maximize public participation. Throughout the public comment period, we received nine comments through social media and email. Four of the nine comments received were not in favor of the proposed cancellations. Five of the nine comments provided alternatives to the proposed cancellations. Upon reviewing the submitted comments, staff is not proposing adjustments to the original proposal, since Line 690 has not been in operation for over a year and the base routing of Line 292 will remain unchanged.

Subject: Executive Board and Governing Board Members Stipend Policy

Recommendation

In accordance with the Executive Board's recommendation, adopt revisions to the Foothill Transit Executive Board and Governing Board Stipend Policy as noted in Attachment A.

Analysis

At the request of the Executive Board, staff presented an overview of the stipend policy at the Strategic Planning Workshop in February 2022. Executive Board Members expressed their concern over the automatic Consumer Price Index (CPI) increases that are included in the current policy, particularly in light of the recent high levels of increases in CPI. The Executive Board members favored a stipend that was more in line with other regional agencies and did not include any automatic increases. The Executive Board evaluated potential options for adjusting the stipend policy at the March Executive Board Meeting.

By way of background, in 1988, at its inaugural meeting, the Board approved stipends for Board Members at \$100 per meeting, limited to two meetings per month. The stipend was adjusted in 2014 when the Governing Board approved increasing the stipend to \$150 per meeting and approved increasing the stipend annually based on the United States Department of labor consumer Price Index (CPI) for the Los Angeles Area and rounded to the nearest dollar.

The table on the below shows the increases to the stipend since the Governing Board approved the automatic CPI increase in 2014 with an effective date of July 2015.

The current stipend amount is \$176 per meeting. Executive Board Members receive a stipend for up to six meetings per month, not to exceed \$1,056 per month. Governing Board Members are not limited to the number of eligible meetings per year. Under the current policy, the stipend is scheduled to be adjusted based on CPI in July 2022 for Fiscal Year 2023.

Below is a table that shows the stipend amount for other agencies in the region.

The new policy is shown in Attachment A. The revisions are as follows; decrease the stipend from \$176 per meeting to \$150 per meeting for Executive Board Members with a limit of \$600 per month (4 meetings) and \$150 for Governing Board Members with no change to the number of meetings. In addition, the stipend amount will be reviewed annually by the Executive Board at the Strategic Planning Workshop and any recommended changes will be included in the next years' Business Plan and Budget.

Purpose and Background

The Governing Board is given the power to define stipend amounts for both the Executive Board and itself. Any Governing Board Members and Executive Board Members who receive a stipend must be considered "employees" of Foothill Transit for IRS reporting purposes. Any Board members wishing to decline the stipend, may do so and will not be reported to the IRS as Foothill Transit employees.

Executive Board Stipend Policy

Executive Board Members shall receive a stipend of \$150 plus United States Department of Labor Bureau of Labor Statistics Los Angeles Area Consumer Price Index (CPI) per meeting when representing the business interests of Foothill Transit, not to exceed one meeting per day or **six** four meetings per month and excluding ceremonial appearances effective July 1, 2015, and increased annually thereafter to the nearest dollar based on the CPI for the month of June. Business interests of Foothill Transit shall include:

Attendance at Executive Board meetings Attendance at Executive Board briefings Participation at relevant transit conferences Participation in transit "fact finding" trips Participation in legislative/public affairs activities

Further, **Executive Board Alternates** who attend meetings in place of an Executive Board Member are eligible for a stipend equal to that of the Executive Board Member based on the above stated formula per meeting not to exceed one meeting per day or <u>six_four_meetings</u> per month.

Governing Board Stipend Policy

Governing Board Members shall receive a stipend of \$150-plus United States Department of Labor Bureau of Labor Statistics Consumer Price Index (CPI) for the Los Angeles Area per meeting, not to exceed one meeting per day, when representing the business interests of Foothill Transit, and excluding ceremonial appearances effective July 1, 2015, and increased annually thereafter to the nearest dollar based on the CPI for the month of June. Governing Board Members will not receive stipends for attendance at Executive Board meetings where they are not serving as an Executive Board

Alternate. In addition, a member of the Governing Board may not receive a stipend as both a Governing Board and Executive Board Member for the same meeting.

The business interests of Foothill Transit for Governing Board Members shall include: Attendance at Governing Board meetings.

Governing Board Alternates who attend meetings in place of a Governing Board Member are eligible for a stipend equal to that of the Executive Board Member based on the above stated formula per meeting not to exceed one meeting per day.

All Executive and Governing Board Members who receive stipends are required to complete Foothill Transit employee documentation as follows: 1) Employment Development Department Withholding Allowance Certificate and Form W4; 2) Employment Eligibility Verification (Form I-9); 3) Voluntary Affirmative Action Record; 4) Direct Deposit Request Form; and 5) Emergency Contact Information Sheet. The stipend payments will be processed with the regular employee payroll and W2 Forms will be distributed after the end of the year.

Any Executive or Governing Board Members who wish to "opt out" of the stipend allowance may do so by contacting the Board Secretary in writing. No stipend will be paid to those Board Members who opt out and no Foothill Transit employee paperwork will be required.

This policy will be reviewed on an annual basis by the Executive Board at the Strategic Planning Workshop. If it is determined that changes are necessary, revisions will be included in the Business Plan and Budget for the next fiscal year.
