The Pledge of Allegiance was led by Governing Board Member Emmett Badar.



#### 4. CONFIRMATION OF AGENDA BY CHAIR AND CHIEF EXECUTIVE OFFICER

After discussion, by Common Consent, the Chair and Chief Executive Officer confirmed the agenda as presented.





#### 5. **RECOGNITION OF PAST BOARD CHAIR CYNTHIA STERNQUIST**

Doran Barnes, CEO, recognized Governing Board Member Cynthia Sternquist, for her two years of service as the Foothill Transit Executive Board Chair.

#### 6. **REVIEW & APPROVAL OF THE MINUTES**

Approval of the minutes for the Governing Board Meeting of May 27, 2022.

Motion by Vice Chair Moss, second by Member H. Manuel Ortiz, the minutes for the Regular Meeting of May 27, 2022, were approved. Motion carried 18-0.

#### 7. INTRODUCTION OF FOOTHILL TRANSIT BUSINESS PARTNERS

Jan Powell, Foothill Transit Advocate, Powell Consulting DC, provided a brief federal legislative update and she reported that the marked-up appropriations bill for transportation included a \$4 million earmark for Foothill Transit's Zero Emission Program.

#### 8. GENERAL PUBLIC COMMENT

Mike Greenspan provided general public comment on changes to the transfer system and having a two-hour transfer window.

Armando Herman provided general public comment on transparency, infrastructure, and he submitted documents for the record.

8.1. Chief Executive Officer Response to General Public Comment

There was no response to General Public Comment by the Chief Executive Officer.

#### 9. FOOTHILL TRANSIT SAFETY & SECURITY UPDATE

Recommendation: Receive and file an update on Foothill Transit's Security efforts.

John Curley, Chief of Safety and Security, presented this item.

Mr. Curley presented an update on Foothill Transit's Public Transportation Agency Safety Plan and security goals. He introduced Gene Luevano, Transportation Security Inspector Surface Operations, Los Angeles' Office, who provided an update on the Transportation Security Administration's



partnership with Foothill Transit.

Staff responded to comments and questions by the Governing Board. Mike Greenspan and Armando Herman provided public comment on Item 9.

The Governing Board received and filed this presentation.

#### 10. PROPOSED FISCAL YEAR 2023 BUSINESS PLAN AND BUDGET

Recommendation: In accordance with the Executive Board's recommendation, adopt Foothill Transit's proposed Business Plan and Budget for Fiscal Year 2023.

Jorge Quintana, Budget and Grants Finance Analyst, presented this item.

Mr. Quintana presented the proposed goals and performance standards, and agency initiatives for Fiscal Year 2023. A \$213.7 million total budget is being proposed, of which \$123.9 million are operating expenses and \$89.8 million are capital investments. Staff expects to operate 878,000 vehicle service hours and anticipates 7.9 million passenger boardings in Fiscal Year 2023.

Member Barakat requested that information be provided that shows the breakdown of technical service calls by CNG bus versus electric bus. There was no public comment on this item.

Motion by Vice Chair Moss, second by Member Moss, to adopt. Motion carried 18-0.

#### 11. GOPASS PROGRAM (FORMERLY FARELESS SERVICE INITIATIVE)

Recommendation: Receive and file the GoPass Program update.

John Xie, Revenue Manager, presented this item.

Mr. Xie provided background information related to Foothill Transit's participation in the GoPass Program. As of May 2022, Foothill Transit has provided 23,400 rides. Currently there are 20 K-12 schools in the Foothill Transit service area participating and four community college districts participating. He also reported on the cost of the program, and how revenue is allocated to each transit agency based on ridership by the school district.

Staff responded to comments and questions by the Governing Board. Mike Greenspan and Armando Herman provided public comment on Item 11.



The Governing Board received and filed this presentation.

#### 12. COVID-19 TRANSIT OPERATIONS UPDATE

Recommendation: Receive and file an update on the continuing impacts of COVID-19 on Foothill Transit's operations.

Tanya Pina, Customer Service and Operations Contract Manager, presented this item.

Ms. Pina provided an update on the L.A. County Public Health Mask Mandate required in all public transportation in Los Angeles County. The mandate was extended on June 14, 2022 for 30 days or when the county's transmission drops to moderate level. She also reported on operational challenges, and ridership and service levels. Average weekday boardings for the month of May were 23,449, representing approximately 60 percent of the ridership levels in the months prior to the Safer-at-Home Executive Order issued in March 2020.

There were no comments or questions by members of the Governing Board. Mike Greenspan and Armando Herman provided public comment on Item 12.

The Governing Board received and filed this presentation.

#### 13. CONTINUED GENERAL PUBLIC COMMENT

Public comment was not reopened as the Public Comment period was concluded earlier in the agenda (Item 8).

#### 14. CHIEF EXECUTIVE OFFICER COMMENT

Comments by Mr. Doran J. Barnes, Chief Executive Officer, Foothill Transit.

Mr. Barnes reported the following:

- Thanked the Governing Board attending the meeting and for their support on the ongoing projects.
- Announced that Foothill Transit received four AdWheel Awards. One of the awards received was for the agency business plan document and a video on the arrival of the double deck bus. The video was played for the Governing Board.



• Announced that the Governing Board will not be meeting in July. The next meeting of Governing Board will be August.

#### 15. BOARD MEMBER COMMENT

Comments by Members of the Foothill Transit Governing Board.

- Member Barakat expressed his concerns over the comments made at the meeting that he found offensive and he has concerns subjecting employees to such comments.
- Member Preciado requested that the meeting be adjourned in the memory of El Monte Police Corporal Michael Paredes and Officer Joseph Santana. He also requested that it be acknowledged on Foothill Transit's social media.
- Vice Chair Moss asked for a formal excusal for Member Ancona, City of El Monte in light of the situation with the El Monte police officers.
- Chair Calaycay stated that the board has a very delicate role at public meetings, because the public has the right to say what they want within the parameters set. He stated the he plans to run meetings orderly and respectful of all. He invited staff to leave the room during public comment if they find comments to be offensive.

#### Foothill Gold Line

At the August 26, 2022, Governing Board Meeting, a representative from Foothill Gold Line will present an update on the agency's projects.

#### San Gabriel Valley Transit Feasibility Study

The San Gabriel Valley Council of Governments (SGVCOG) in partnership with Los Angeles Metro is conducting a feasibility study to evaluate and improve mobility in the San Gabriel Valley. An update will be presented at the August 26, 2022, Governing Board Meeting.

#### **Cluster 3 Special Election Notification**

At the August 26, 2022, Governing Board Meeting, Cluster 3 consisting of the cities of Arcadia, Bradbury, Duarte, Monrovia, Temple City, and Pasadena will receive notification of a Special Election that will be held on September 30, 2022. The Executive Board Alternate position for Cluster 3 is currently vacant.

The vacancy was created with the passing of Governing Board Member Tzeitel Paras-Caracci. An election must be held by the members of Cluster 3 to select an individual to serve the remainder of the term, which runs through May 2023.

#### **Rose Bowl Service Update**

For more than two decades, the Rose Bowl Operating Company (RBOC) has contracted with Foothill Transit to provide shuttle service between the parking lot of the Parsons building in Pasadena and the Rose Bowl. The most recent contract expired on August 5, 2022. In July of this year, the RBOC issued a Request for Proposals (RFP) seeking shuttle services to and from the Rose Bowl Stadium for Major Events.

Under the Federal Transit Administration Charter Bus Service Regulations, federally funded public transit agencies are restricted from operating chartered services with limited exceptions. An exception to this rule applies when no registered charter provider (RCP) responds to a notice sent by a

recipient of federal funds. We issued the required notice to registered charter providers and, because no RCPs submitted proposals to operate the service, we are allowed to contract with the RBOC to provide the shuttle services.

On August 4, 2022, the RBOC board awarded the Rose Bowl Stadium Shuttle Service contract to Foothill Transit for a term of five years with two one-year options to extend the contract at the discretion of the RBOC. The contract term commenced on August 6, 2022, and Foothill Transit provided shuttle service for two music festivals this month and will provide service to the UCLA home Football games, which start on September 3, 2022, in addition to a variety of other events.

#### **Insurance Program Update**

At the October 2021 Executive Board meeting, staff updated the Board about how all the usual business-related insurance coverages such as general liability, property, earthquake, workers' compensation for all Foothill Transit employees, and automobile insurance for our non-revenue fleet, etc. insurance is purchased and how Foothill Transit utilizes the services of Alandale Insurance as its insurance broker. At the meeting, staff communicated a substantial increase in premiums to our general and excess liability policies mainly due to our official name including the word "transit", typically a red flag for insurers and one that we've been able to work through prior to 2021. However, a recent "shock case" has changed the dynamic significantly and was one of the reasons that prompted a Special Executive Board meeting on July 8, 2022.

On July 8, 2022, at the special meeting, staff again communicated how Foothill Transit is unique as a transit operator with all transit services contracted out to private entities. Insurance agencies often have difficulty understanding the unusual nature of our insurance and liability exposure, and this current "shock case" has exacerbated that issue. As a result, the Executive Board authorized the CEO to issue payments totaling \$1,068,914.81 to bind Foothill Transit's Fiscal Year 2023 insurance coverages. The Board also approved increasing our coverage and made a motion to add another \$10M layer, taking our coverage to \$21 million. The fiscal impact is significant and although staff planned for an increase in the Fiscal Year 2023 budget, it was not enough to cover these increased amounts. Nonetheless, funding was identified and staff continues to explore other options, like the Joint Powers Insurance Agency (JPIA) and the California Transit Indemnity Pool (CalTIP), for future strategic risk management planning.

#### **Overview of Service Change Process**

In an effort to adapt to the ever-changing environment that exists throughout transportation, Foothill Transit has bi-annual service changes implemented in or around spring and fall each year. However, this can be subject to change. Service changes are undertaken to modify service based on customer and/or budget fluctuations to improve system performance. Our staff conducts regular analyses to improve performance, including the monitoring of customer or stakeholder comments, on-time performance, and ridership trends.

Each change in service involves a number of critical steps. These include, but are not limited to:

- Analysis of current service levels, ridership, and changes related to housing and business development along a route, planned long-term detours, etc.
- Development of the new bus schedules
- Analysis of fleet impacts
- Contractor analysis of staffing impacts and scheduling of operator assignment bids
- Production of customer communication materials

The next schedule change will take place on Sunday, September 25, 2022. Along with routine adjustments to travel times along several lines, the changes below will also be implemented:

#### <u>Line 188</u>

Routing adjustment in Claremont and Montclair to improve accessibility to key destinations

#### <u>Line 289</u>

Increased frequency on the weekends to align with our minimum route standard of 60-minute headway
