15. REQUEST TO ISSUE IFB - QUALITY ASSURANCE SUPPORT VEHICLES

Recommendation: 1. Rescind the contract award to Theodore Robins Ford for four Hybrid SUV Quality Assurance support vehicles; and

2. Authorize the Executive Director to issue Invitation of Bids (IFB) No. 12-019 for four hybrid-electric Quality Assurance support vehicles to replace the four vehicles currently in the fleet. (11-3847)

Kevin McDonald, Deputy Executive Director, Foothill Transit, presented this item and reported that on March 25, 2011, the Executive Board authorized the award of a contract for the purchase of four Ford Escape Hybrid - electronic SUV's, to Theodore Robins Ford. The contract specified delivery of the vehicles within 16 weeks of placement of the order. To date, production of these vehicles has not begun and Ford has indicated that they do not have a projected date to begin production of the vehicles ordered. As a result staff would like to reevaluate vehicles currently available on the market, and therefore, requests that recommendation No. 2 be removed.

24. SAN GABRIEL VALLEY PARK AND RIDE - CITY OF INDUSTRY

Recommendation: 1. Authorize the Executive Director to amend Agreement No. 11-038 with Walker Parking Consultants for Phase II Parking Design Services for the Industry Park and Ride in the amount of Five Hundred Fifty Four Thousand Four Hundred Forty Dollars(\$554,440);

- 2. Provide direction on the design element of the Park & Ride structure; and 3. Authorize the Executive Director to issue an Invitation for Bids (IFB) for the construction of the Industry Park & Ride. (11-3857)
- Roland Cordero, Director of Facilities, Foothill Transit, presented this item, and announced that a groundbreaking ceremony is anticipated in late October 2011 for Phase II of the project. Kevin Walker, Walker Parking Consultants, was available at the meeting to respond to questions regarding the project.

Mr. Barnes noted that the color scheme for the park and ride structure will be modified using Foothill Transit color schemes, as well as installing Foothill Transit signage.

After discussion, on motion of Member Tessitor, seconded by Vice Chair Wallach, unanimously carried, this item was approved.

VI. EXECUTIVE DIRECTOR COMMENT

25. Comment by Mr. Doran Barnes, Executive Director, Foothill Transit Executive Board. (11-3768)

Mr. Barnes reported the following:

- A special meeting of the Foothill Transit Governing Board is scheduled for Wednesday, September 14, 2011 at 7:45 a.m.

VII. BOARD MEMBER COMMENT

26. Comments by the Members of the Foothill Transit Executive Board. (11-3767)

Member Chandler expressed concern regarding comments received at today's meeting during public comment on the proposed park and ride in the City of Azusa, and suggested that an item be considered for discussion at a subsequent meeting, or referred to closed session for a conference with Legal Counsel at today's meeting.

Darold Pieper, General Counsel, advised the Executive Board about the legal requirements for adding a closed session item to today's agenda. Therefore, there was a motion by Member Chandler, seconded by Treasurer Lantz, to (1) find that subsequent to the posting of the agenda it came to the attention of the agency that serious controversy had arisen over the proposed Azusa Park and Ride; (2) find that there is a need for the agency to take immediate action because at least a month's worth of ongoing expenditures for consultants would be lost if the project is not feasible, needs to be cancelled, and an evaluation of the situation is deferred until the Executive Board's September meeting; and to (3) add a closed session item for a "Conference With Legal Counsel - Anticipated Litigation Initiation of litigation pursuant to Government Code Section 54956.9 (c): One Case" to the agenda as authorized by Section 54954.2(b)(2) of the Brown Act. The motion was unanimously carried, and this item was added as a closed session.

Vice Chair Wallach commented on concerns raised by a member of the public regarding lifts on Foothill Transit buses. In response to concerns raised, Mr. Barnes confirmed that all Foothill Transit buses are ADA compliant and that Foothill Transit continues to explore alternatives to enhance buses for the disabled community.

The Foothill Transit Executive Board recessed to Closed Session at 9:35 a.m. following Agenda Item No. 26. The Foothill Transit Executive Board meeting was reconvened and called to order by Chair Herrera, at 10:10 a.m. with the following members Present: Chair Herrera, Vice Chair Wallach, Treasurer Lantz, and Members Chandler and Tessitor.
