Recommended Action: Revise the Foothill Transit Executive Board and Governing Board Members Stipend Policy as follows: 1. Increase the stipend for the Executive Board and Governing Board annually based on the United States Department of Labor Consumer Price Index (CPI) for the Los Angeles Area and rounded to the nearest dollar, effective July 1, 2015; and 2. Increase the Executive Board maximum number of meetings per month eligible for a stipend from four to six effective July 1, 2015; and 3. Increase the stipend for Executive and Governing Board Alternates when representing Foothill Transit business annually based on CPI for the Los Angeles area and rounded to the nearest dollar effective July 1, 2015.
