#### **III. PRESENTATIONS**

- 6. FOOTHILL TRANSIT PROGRAM UPDATES
  - 6.1 BUS STOP ENHANCEMENT PROGRAM (BSEP) (12-4803)
  - In the Fiscal Year 2012 Business Plan, the Governing Board approved \$1,000,000 to fund the Bus Stop Enhancement Program. Funding for the Bus Stop Enhancement Project has been carried over into the Fiscal Year 2013 Business Plan to provide additional grants to the member cities. This plan provides member cities with financial assistance to improve locations. The Program's overall goal is to improve the customer experience while waiting for the bus. The Program also aims to:

 strengthen community identity, 2) provide safety-related amenities,
improve bus stop technology, 4) reinforce the positive image of Foothill Transit, and 5) attract new customers.

 Pending Executive Board approval of the Fiscal Year 2013 Program, a call for applications will be issued to Joint Power Authority member cities and the County of Los Angeles, for projects in which Foothill Transit will provide funding up to \$35,000 to each city based on established criteria.

- Cities implementing additional amenities such as innovative lighting, drinking fountains, or supplemental devices for the disabled, as well as passenger related technology, will be eligible to receive an additional \$5,000.
- A recommendation will be forwarded to the Executive Board at the October 26, 2012, meeting seeking approval of the Program criteria and schedule. Upon approval, a call for applications is tentatively scheduled for November 2012. Applications will be evaluated in January 2013, followed by a notice to the qualified applicant in February 2013, in order for an agreement to be executed in March 2013.

# 6.2 PARK & RIDES UPDATE (12-4804)

Roland Cordero, Director of Facilities, presented this item and reported the following:

# Industry Park & Ride Project

- Plans approved by Los Angeles County on April 2012
- Construction Information Bids issued on May 16, 2012
- Executive Board approved contract with Klorman Construction in the amount of \$9,530,932
- Metrolink riders were notified of upcoming construction
- Demolition began on October 2, 2012
- Project duration is anticipated for 11 months
- Estimated project completion is August 2013

# Azusa Park & Ride Project

- Azusa City Council requested further analysis of Alternative sites
- Foothill Transit will contribute to the facility maintenance cost
- Architect and Environmental Consultant are working on Alternative Sites Analysis
- Expanded Environmental Impact Report is expected to be completed by March 2013

# West Covina Transit Center Park & Ride Project

- Park and Ride calls for a 12-Bus Berth Transit Center and approximately 500 Space Park & Ride
- Executive Board approved the Memorandum Of Understanding with City of West Covina and Westfield Development

- West Covina City Council considered and approved the Memorandum Of Understanding on October 16, 2012
- City of West Covina will address property ownership with city's Oversight Board

# Diamond Bar Park & Ride Project

- A multi-level parking structure at 100 North Diamond Bar Blvd.is proposed
- Caltrans intends to relinquish Diamond Bar Park & Ride to the City of Diamond Bar
- Foothill Transit will eventually own the property
- A Memorandum Of Understanding between Foothill Transit and City of Diamond Bar was reached
- Architectural & Engineering firm and Environmental Consultant are working on the Environmental Impact Report process
- 6.3 MT. SAN ANTONIO COLLEGE STUDENT RIDERSHIP PILOT PROGRAM (12-4805)

Felicia Friesema, Director of Marketing and Communication, Foothill Transit, presented this item and reported the following:

- Student ridership programs across the country account for 11% of the public transportation users.
- The success of two ridership programs Foothill Transit has in place with Rio Hondo College and the Pasadena City College led to discussions on the implementation of a pilot ridership program at Mt. San Antonio College (Mt. SAC).
- The projected cost of Mt. SAC Student Ridership Pilot Program is \$231,000, which includes: 1) the cost of fare revenue that would not be collected from the students during the pilot period, and 2) the cost of marketing materials that will be developed to promote the Program.
- Councilmember Antonio Cartagena, City of Walnut, thanked Foothill Transit for including Mt. SAC in the program.
- Doran Barnes, Executive Director, Foothill Transit thanked Councilmember Cynthia Sternquist, Temple City, for assisting and arranging a meeting with the Mt. SAC Board of Directors.

• Councilmember Marlen Garcia, Baldwin Park, suggested that Citrus College should be included in the ridership program and Treasurer Paula Lantz suggested that Azusa Pacific College should also be included in the program. Members in attendance indicated they will assist Foothill Transit in the implementation of the ridership program.

# 6.4 SILVER STREAK/SILVER LINE COORDINATION & OPENING OF EL MONTE STATION (12-4806)

Felicia Friesema, Director of Marketing and Communication, Foothill Transit, presented this item and reported the following:

The El Monte Station is a Metro Station. Foothill Transit shares the building with Metro. Foothill Transit focused on the following marketing strategies for the opening of the El Monte Metro station:

- A Shared marketing campaign
- Brochures

In response to Member Antonio Cartagena, Ms. Friesema stated the fare structure on the Silver Streak Line is the same for Metro and Foothill Transit.

Member Cartagena, inquired about food facilities in the station. Mr. Doran Barnes, Executive Director, reported the facility is being run by Metro and Foothill Transit is only in charge of the office provided to Foothill by Metro.

# 6.5 BUDGET VS. ACTUAL SYSTEM PERFORMANCE (12-4807)

Joe Raquel, Director of Planning, presented this item and reported on ridership comparisons, budgeted vs. actual, covered during Fiscal Years 2006 through 2012. Ridership comparisons were achieved using projections given in Foothill Transit's Business Plan. Over all, the ridership numbers projected vs. the actuals achieved varied slightly; numbers were very close. The trends that may have contributed to a variance in ridership were economy and fuel prices.

- "The Pomona Valley Bicycle Coalition" has been working to bring a regional CicLAvia to Pomona. Community members have finalized a proposed route to be tested on Sunday, October 28th.
