### 5.2 Presentation by Assembly Member Mike Eng (11-5450)

David Reyno, introduced Assemblymember Mike Eng, who represents the 49th Assembly District, located within eastern Los Angeles County and includes the Cities of Alhambra, El Monte, Monterey Park, Rosemead, San Gabriel, San Marino, and South El Monte.

Assemblymember Eng chairs the Assembly Committee on Banking & Finance, which oversees California's financial institutions, real property finance, and corporate securities law. The Committee develops and shapes public policy in a broad range of areas such as mortgage foreclosure, payday lending, the regulation of state chartered banks and credit unions, consumer lending, and financial privacy. Assemblymember Eng has a wide range of other important assignments, including membership on the Assembly Committee on Business and Professions, Education, Health and Transportation.

Assemblymember Eng stated the State of California has three (3) transportation issues: 1) High Speed Rail, 2) Congestion Pricing and 3) Budget. He briefly elaborated on each issue and reported that the State of California is the only participant of Congestion Pricing and to date has

received \$250 million from the Federal Government for the initial study. Congestion Pricing is a way of harnessing the power of the market to reduce the waste associated with traffic congestion. Congestion Pricing works by shifting purely discretionary rush-hour highway travel to other transportation modes or to off-peak periods, taking advantage of the fact that the majority rush-hour drivers on a typical urban highway are not commuters. By removing a fraction (even as small as 5 percent) of the vehicles from a congested roadway, pricing enables the system to flow much more efficiently, allowing more cars to move through the same physical space.

Assemblymember Eng reported that Foothill Transit Board Members have played a vital role in saving the Transportation Fund.

Doran Barnes, Executive Director, Foothill Transit, and Chair Herrera thanked representative Eng for his support of transportation funding and for attending the Foothill Transit meeting.
