16. AMENDMENT TO PULSAR ADVERTISING CONTRACT (NO. 12-038)

Recommended Action: Approve an amendment to the Pulsar Advertising general marketing Contract (No. 12-038) in the amount of \$213,627, for: The development and implementation of a College Pass Marketing Program for both the 15-month Mt. SAC Class Pass pilot program and the University of La Verne Class Pass pilot program (\$115,990).
