Yoko Igawa introduced Foothill Transit's federal advocate Jan Powell, who provided a federal legislative update. Ms. Powell reported on the second continuing resolution passed on December 20, 2024, which extends federal spending through March 15, 2025, the 119th Congress, and the confirmation of Sean Duffy as the next Transportation Secretary.

At the state level Ms. Igawa reported on an advocacy trip to meet with Foothill Transit's state delegation. She also introduced Foothill Transit's state advocate Steve Wallauch, who provided a state legislative update. He reported on the proposed FY 2025-26 budget.

The Governing Board received and filed the January 2025 Legislative Update presentation.

11. NOTIFICATION OF CLUSTER 3 SPECIAL ELECTION

Recommendation: Receive notification of Cluster 3 Special Election to be held on March 28, 2025, for the Executive Board Alternate position.



Christina Lopez, Board Secretary, presented this item.

Cluster 3 consisting of the cities of Arcadia, Bradbury, Duarte, Monrovia, Pasadena and Temple City received notification of the upcoming special election scheduled for March 28, 2025. Cluster 3 will be electing an Executive Board Alternate. The elected Governing Board Member will serve the remaining term, which extends through May 2026.

The Governing Board received notification of Cluster 3 Special Election to be held on March 28, 2025.

12. LINE 492 PILOT PUBLIC OUTREACH RESULTS

Recommendation: Authorize the Chief Executive Officer to adopt the increased frequency of Line 492.

Henry Lopez, Transit Planner, presented this item.

Mr. Lopez presented the results of the public outreach for the one-year pilot for Line 492. Line 492 has been operating at a 20-minute frequency since April 2024. Ridership on Line 492 has increased 17 percent since implementing the 20-minute frequency in April 2024. He reported that 16 comments were received, all in favor of permanently increasing the frequency to 20-minutes.

Motion by Member Calaycay, second by Vice Chair Shevlin, to approve. Motion carried 18-0.

13. ROSE BOWL SERVICE UPDATE

Recommendation: Receive and file the Rose Bowl Service Update.

Ali Showkatian, Director of Customer Service and Operations, presented this item.

Mr. Showkatian provided a service overview of Foothill Transit's shuttle service for Rose Bowl events. Shuttle service was provided for the Pasadena Half Marathon, Pokemon Go weekend, two music festivals, UCLA football games, and the 2025 New Year's Day Rose Bowl Game. During 2024, Foothill Transit provided shuttle services for 12 events and transported 72,648 customers. A preview of the 2025 season was also presented.

Staff responded to comments and questions from the Governing Board



regarding potentially picking up at Memorial Park, number buses used to provide service, and safety precautions.

The Governing Board received and filed the Rose Bowl Service Update presentation.

14. CHIEF EXECUTIVE OFFICER COMMENT

Comments by Mr. Doran J. Barnes, Chief Executive Officer, Foothill Transit.

Mr. Barnes reported the following:

Recommendation

The attached Financial Statements and Investment Report summarize Foothill Transit's unaudited operations and financial condition as of February 28, 2025, for the fiscal year (FY) ending June 30, 2025.

Balance Sheet Analysis (Attachment A):

Assets

The balance sheet, as of February 28, 2025, shows total assets at \$425.69 million. This total consists primarily of \$197.77 million in fixed assets, \$204.28 million in cash and investments and \$23.32 million in receivable and prepaid assets. Foothill Transit's cash position of \$204.28 million is \$5.30 million less than the previous month, and is \$8.34 million more than last year in February.

Liabilities

The accounts payable and accrued liabilities balance is \$15.67 million. Accounts payables and accrued liabilities include operation and maintenance expenses for \$13.08 million and \$1.68 million for fuel.

The deferred revenue of \$154.64 million represents funds that are reserved for planned capital expenditures, such as, upcoming bus procurements and security enhancements, and construction activities at Arcadia-Irwindale and Pomona yards.

Our current investments are held in financial instruments pursuant to Foothill Transit's investment policy. The cash balance includes \$64.23 million in liquid accounts held with Bank of Montreal (BMO) and \$55.84 million in interest bearing money market accounts with BMO.

The current interest rates on all accounts are included on Attachment B. The LAIF investment and the CD investments earn interest and are held for future capital and operating funding requirements.

Foothill Transit invested \$70.14 million in the Local Agency Investment Fund (LAIF), and invested funds in multiple certificates of deposit (CDs) with staggered maturity dates to minimize any potential cash flow concerns. The total return of investment for these CDs is projected to be \$0.56 million and potentially more when funds are re-invested after maturity. The breakdown of the investments is listed on Attachment B.

Operating and Capital Revenues and Expense Analysis (Attachment C)

Fare revenues FY to date were up 8.59% compared to budget due to gradual ridership increases in the Los Angeles Region. TAP stored value usage have been gradually increasing throughout the FY as ridership experienced a similar increase. Metrolink revenues are deviating from the budgeted number due to an updated lowered average cash fare calculated that is used for reimbursement. The lower average cash fare will be used for the remainder of the FY.

Revenues for FY25 reflect application of the American Rescue Plan Additional Assistance (ARPA) federal funds. To date, Foothill Transit has spent \$25 million of the emergency federal funds on operating expenses.

Operating costs through February 2025 were \$98.12 million, which is \$9.05 million less than the budget and \$11.76 million more than February 2024. The variance in operating cost as the new contract for the Arcadia Operations and Maintenance facility started in late March 2024. Of the \$98.12 million expenditures, \$77.43 million reflects operating costs for the Arcadia-Irwindale and Pomona operations contractors. Other operating expenses include fuel, which was \$7.21 million through February 2025.

Capital expenditures through February were \$10.16 million compared with \$10.66 million last year at this time. The annual budget for capital expenditures includes the procurement and construction of 19 zero-emission buses and a security enhancements at the Arcadia-Irwindale and Pomona operations and maintenance facilities, and CNG equipment replacement at the Pomona operations and maintenance facility. Due to the need to re-procure

the 19 buses originally awarded to El Dorado, Foothill Transit has awarded a contract to New Flyer and anticipates the cost of these buses will be incurred in FY 2025.

Total Disbursements (Attachment D)

Total disbursements reflect invoices paid for the month of February 2025; they do not reflect the total expense incurred for the month. If an expense has been incurred but not yet invoiced or paid, Foothill Transit accrues the expense to track the expenses properly during the month in which they actually occurred. Total disbursements for February 2025 were \$13.74 million. Capital disbursements totaled \$2.91 million and other significant disbursements include \$1.32 million to Keolis and \$7.67 million to Transdev for bus operating services.

Subject: Los Angeles 2028 Olympics Games (LA28) Update

Recommendation

Receive and file the Los Angeles 2028 Olympics Games (LA28) Update.

Analysis

Joseph Forgiarini serves as LA Metro's Senior Executive Officer, Service Development and is leading the planning for public transit services for the Los Angeles 2028 Olympics Games. Mr. Forgiarini will be joining the Foothill Transit Governing Board meeting to provide an update on the transit planning efforts. The information below is provided as background to Mr. Forgiarini's presentation.

Forty-four years after the City of Los Angeles hosted the 1984 Olympics Games, the city once again will be hosting this monumental event in 2028. Hosting the Olympics will generate significant tourism leading up to, during, and after the games. While a significant portion of the games will take place in the City of Los Angeles, events will be spread out through the Los Angeles greater region. The LA28 Olympics will be considered a "Transit-first Games" with little or no car parking available for spectators at competition venues. To prepare for this, LA28 has partnered with Los Angeles County Metropolitan Transportation Authority (LA Metro), to implement Metro 2028 Games Mobility Concept Plan.

The Metro 2028 Games Mobility Concept Plan is led by various mobility stakeholders including LA 2028, City of Los Angeles, LA Metro, LADOT, CalTrans, MetroLink, and SCAG who make up the Games Mobility Executives (GME). The key delivery roles of the GME include overall games transportation program, open and closed transportation systems, regional/local traffic operations, games mobility hubs, venue operations, and Transportation Demand Management (TDM) planning and communications.

LA Metro currently maintains two major asks of transit agencies, number one to provide end-of-life bus donations for the LA28 contingency fleet, and number two to provide bus operators and mechanics for game day

operations. In order to fulfill the objective of a "Transit-first Games," one of the major projects that LA metro is implementing is the Supplemental Bus System (SBS) program. The majority of existing parking at games venues will be utilized for essential temporary Games overlay, security, and transportation operations, therefore spectators will not have access to on-site parking. Foothill Transit is anticipating to retire 49 buses between 2026 and 2027. Foothill Transit's Procurement department currently maintains an Asset Disposition policy, and under the policy we have authority to donate fully depreciated assets to other government agencies when appropriate.

There are still questions that remain unanswered, how will the games transportation be funded; what events will require Foothill Transit support; what level of support is needed; Although the formal request has not been received, there is an expectation that LA Metro will be requesting Foothill Transit's support for events taking place at the Rose Bowl. Foothill Transit maintains extensive experience providing operational services for Rose Bowl's Park and Ride shuttle service. Throughout the two weeks of games, it is anticipated that close to 800,000 tickets will be sold for eight Rose Bowl related events. LA Metro will be providing an update during the Governing Board meeting.

Foothill Transit currently participates in various LA28 committees including LA Metro's SetGO Playbook Task Force, LA Metro's Thought Leadership Task Force, and TSA's Transportation Subcommittee.

Subject: Financial Forecast

Recommendation

Receive and file the update to Foothill Transit's financial forecast for fiscal year 2026.

Analysis

Each year, finance staff prepares an overall financial review that encompasses an overview looking both at historical performance and forecasts the future to ensure we maintain an operating and capital financial base sufficient to deliver our mission. The financial forecast summarizes operating and capital revenues and expenses from FY 2021 through FY 2030. The forecast is based upon assumptions that are a combination of 1) historical performance; 2) known economic impacts; and 3) professional regional forecasting used by transit operators in the region. We have provided the audited financial data for fiscal years 2021 through 2024, consistent with the organization's Annual Comprehensive Financial Report (ACFR). Foothill Transit has prepared an operating and capital financial forecast for FY 2026 with assumptions for FY 2026 through 2030.

Operating Forecast

For the upcoming year, we have used our preliminary budget proposal and multi-year contracts to prepare our operating forecast. We anticipate to end fiscal year 2025, approximately \$13.4 million (8%) under the approved operating budget of \$161,665,940. Looking ahead to FY 2026, we anticipate a budget proposal of \$174,344,450. This expected budget increase is attributed to contractual increases, increased fuel costs for compressed natural gas (CNG) and a growing hydrogen fleet. From FY 2027 through FY 2030, we are forecasting operating budget increases of 4%, 8%, 10%, and 5%, assuming minimal growth in non-purchased transportation related expenses at a conservative rate of 5%.

With respect to operating revenues, Foothill Transit is using the most recent draft funding marks provided by the Los Angeles County Metropolitan Transportation Authority (LA Metro) and estimates for fare revenue consistent with ridership trends. Based off a recent memo provided by LA

Metro, there was a \$300 million revenue shortfall in the region during FY 2024 and that will impact the available funding in FY 2026. Per Metro's provided formula allocation, we should anticipate to receive approximately \$106 million of revenues. Despite the drop in sales tax, fare revenue is anticipated to increase with the continued ridership growth we are experiencing. Foothill Transit also intends to use federal formula funds for preventive maintenance, which will assist in addressing the funding shortfall.

Subsequently, LA Metro is anticipating another revenue shortfall in FY 2025 of about \$550 million (9.3%). Using this data, we have accounted for the expected shortfall in FY 2025 and forecasted a conservative growth rate of 1% in FY 2027 through 2030. FY 2027 will be an overall net reduction as the 9.3% shortfall from FY 2025 will be absorbed in that fiscal year. So as the operating expense budget will increase from FY 2027 through FY 2030, the operating revenues will decrease initially by 8% and grow by 1% from 2028 through 2030. Despite the discrepancy between expense and revenue growth, Foothill Transit can fully fund its operations through FY 2028 with a \$10.5 million shortfall in FY 2029 that can be addressed with budget adjustments.

Capital Forecast

Similar to the operating forecast, for the upcoming year, we have used our preliminary budget proposal to develop the capital forecast. Foothill Transit currently has a total life of project budget allocation of \$289,398,511 across 72 capital projects. The expected capital cash flow for FY 2025 was \$107.5 million, however, we expect to end the year having spent \$16.0 million. This discrepancy is due to production delays for 19 hydrogen fuel cell buses and 24 battery-electric double deck buses as well as a delay for construction of the Arcadia/Irwindale hydrogen fueling station. Looking ahead to FY 2026, we have carried over much of the prior year capital allocation and anticipate to spend approximately \$131.8 million across a total life of project budget allocation of \$325.4 million for 64 projects. The proposed capital program has several projects with planned expenditures to 2030, however, for FY 2027 through 2030, we have assumed no additional bus purchases outside of what is in the current capital program, approximately \$5 million of new projects in each year, and hydrogen station upgrades for the Pomona facility in 2028.

With respect to capital revenues, Foothill Transit has used the most recent draft funding marks provided by LA Metro and no assumptions for new grant awards. Most of the capital revenues are federal formula funds which have been prioritized for bus replacement and zero-emission infrastructure;

however, beginning in FY 2026, we anticipate to flex some of these funds to operating to pay for preventive maintenance. Using the same assumptions for capital revenue growth as we did for operating revenues, we have prepared a capital forecast through FY 2030. Despite the conservative assumptions, Foothill Transit anticipates to fully fund its capital program through 2030.

Grant Revenues

Within the financial forecast there are no new assumptions of competitive grant awards, but all successful applications are reflected. In FY 2025, Foothill Transit was successful in applying for and receiving \$105.4 million of new discretionary grants. This funding is spread across federal, state, and local funding sources for specific projects or activities. The team will continue to aggressively pursue grant funding for all eligible activities to alleviate the funding limitations currently forecasted in FY 2026 and beyond.

Financial Impact

Using the assumptions in our financial forecast, Foothill Transit's proposed FY 2026 budget is expected to be balanced between revenues and expenses. All unspent revenues from the FY 2025 budget allocation will be repurposed for FY 2026 unless designated for a specific activity or project. As Foothill Transit approaches the fiscal year-end, the financial forecast will be updated with the final allocation of revenues for FY 2026 and the audited year-end financials for FY 2025.

Subject: Bus Stop Enhancement Program (BSEP) Update

Recommendation

Receive and file the Bus Stop Enhancement Program (Attachment A) Update.

Analysis

Currently, there are 1,722 bus stops in Foothill Transit's service area, of which Foothill Transit only owns the stops located at the Azusa Intermodal Transit Center, Industry Park & Ride, Covina Transit Center, and Mt. Sac Transit Center. Foothill Transit also leases the stops at the Puente Hills Mall Transit Center, but the remaining stops are either city, county, or state owned.

In FY 1997, with Transit Development Act funds, Foothill Transit developed the Bus Stop Enhancement Program (BSEP) to provide financial assistance to member cities, counties, and the state who are interested in making improvements to their bus stops serviced by Foothill Transit. In September 2022, the Executive Board approved to expand BSEP participation to Class Pass participating schools as some bus stops serviced by Foothill Transit are located on school campuses or properties not owned by member cities, counties, or the state.

With the philosophy that a bus stop is the start of a customer's experience, Foothill Transit continues to fund the BSEP to help entities such as member cities, counties, the state, and Class Pass participating schools to improve or add to their existing bus stop amenities. Popular bus stop improvements include solar lighting, shelters, benches, and trash receptacles.

Next Steps

Foothill Transit will be accepting applications and providing BSEP funding for BSEP projects in FY 2026. Ten cities will be awarded up to \$40,000, totaling \$400,000 for the entire program during FY 2026.

Foothill Transit encourages all member cities, counties, the state, and Class Pass participating schools to apply for BSEP funds to enhance all aspects of their existing bus stops serviced by Foothill Transit. All member cities,

counties, the state, and Class Pass participating schools within Foothill Transit's service area are eligible to apply for BSEP funds.

Funds may be used for physical improvements and for purchase of bus stop amenities (including, but not limited to, shelters, benches, trashcans, and tree grates). All costs, including installation and labor, must be paid by the successful applicant and will be reimbursed by Foothill Transit at the completion of the project. Bus stops not serviced by Foothill Transit are ineligible for BSEP funding.

Application submissions for BSEP funding will be accepted starting July 1, 2025.

Budget Impact

Funding for the Bus Stop Enhancement Program was included into the FY 2026 capital budget.

Analysis

The Bus Roadeo competition is a premier event that promotes safety, professionalism, and excellence among maintenance technicians and coach operators—the frontline representatives of our transit system. This event provides Foothill Transit operators and mechanics with a platform to demonstrate their expertise in a highly competitive setting.

Transit agencies across North America host Bus Roadeos to identify topperforming operators and maintenance teams who advance to regional and national competitions while reinforcing best practices in safety, efficiency, and customer service. The American Public Transportation Association (APTA) International Bus Roadeo, in particular, serves as a key industry event, fostering knowledge-sharing and professional development among transit professionals.

On February 22, 2025, Foothill Transit held its 28th Annual Bus Roadeo at the Arcadia/Irwindale Operations and Maintenance Facility. The competition featured three three-person maintenance teams and 33 coach operators representing both of Foothill Transit's service contractors.
