Mr. Quintana reported that a \$174.5 million budget is proposed for Fiscal Year 2026 for operating expenses and \$17.6 million budget is proposed for capital investments. The agency expects to operate approximately 879,994 vehicle service hours and anticipates 11.1 million passenger boardings. He also presented the goals and performance targets, and proposed initiatives for Fiscal Year 2026.

Mr. Curley reported that Foothill Transit continues its active participation as a founding member of the Transit Mutual Assistance Compact (TransMAC), a regional mutual aid agreement. To date, TransMAC includes 27 transit agencies and aims to ensure service continuity through the sharing of buses, personnel, and equipment during emergencies.

#### 14. CHIEF EXECUTIVE OFFICER COMMENT

Comments by Mr. Doran J. Barnes, Chief Executive Officer, Foothill Transit.

Mr. Barnes reported the following:

- Governor Newsom's proposal to renew the Cap-and-Trade program and rebrand as Cap-and-Invest, redirects \$1.5 billion a year from transportation to fund Cal Fire. Staff is monitoring closely as it limits the ability to compete for capital funding.
- Staff continues to closely monitor the financial imbalance projected around the 2030 timeframe.
- Priority efforts are focused on the Bronco Mobility Hub to bridge the \$10 million gap between the life of project budget and the anticipated amount it will cost to complete the project. Staff is exploring funding opportunities across federal, state, regional, and county levels.
- Staff is working with LA Metro on the 2028 Olympics planning. While planning efforts are progressing, the regional transportation program is expected to require \$2—\$3 billion to support the event.



- The Executive Board agenda includes two recommended contract awards for the Arcadia/Irwindale hydrogen fueling infrastructure design-build and the purchase of 30 additional hydrogen fuel cell electric buses.
- Felicia Friesema, Director of Marketing and Communication, announced Doran Barnes is the recipient of the 2025 Edmund G. Pat Brown Award.

#### 15. GOVERNING BOARD MEMBER COMMENT

Comments by Members of the Foothill Transit Governing Board.

- Member Preciado commended a Silver Streak Coach Operator for handing a difficult situation with an individual onboard the bus exceptional well. He also shared his first enjoyable experience riding Foothill Transit's double decker bus from Downtown LA to Montclair.
- Member Chen shared his experience riding the Silver Streak and expressed appreciation for the Safety and Security personnel he observed onboard.

#### Recommendation

The attached Financial Statements and Investment Report summarize Foothill Transit's unaudited operations and financial condition as of June 30, 2025, for the fiscal year (FY) ending June 30, 2025.

#### **Balance Sheet Analysis** (Attachment A):

#### Assets

The balance sheet, as of June 30, 2025, shows total assets at \$418.84 million. This total consists primarily of \$191.36 million in fixed assets, \$200.81 million in cash and investments and \$26.38 million in receivable and prepaid assets. Foothill Transit's cash position of \$200.81 million is \$2.94 million less than the previous month, and is \$4.44 million more than last year in June.

#### Liabilities

The accounts payable and accrued liabilities balance is \$14.16 million. Accounts payables and accrued liabilities include operation and maintenance expenses for \$10.81 million and \$1.57 million for fuel.

The deferred revenue of \$157.33 million represents funds that are reserved for planned capital expenditures, such as, upcoming bus procurements and security enhancements, and construction activities at Arcadia/Irwindale and Pomona facilities.

Our current investments are held in financial instruments pursuant to Foothill Transit's investment policy. The cash balance includes \$65.62 million in liquid accounts held with Bank of Montreal (BMO) and \$55.43 million in interest bearing money market accounts with BMO.

The current interest rates on all accounts are included on Attachment B. The LAIF investment and the CD investments earn interest and are held for future capital and operating funding requirements.

Foothill Transit invested \$71.69 million in the Local Agency Investment Fund (LAIF), and invested funds in certificates of deposit (CDs). The total return of investment for the CD account is projected to be \$261.3 thousand and potentially more when funds are re-invested after maturity. The breakdown of the investments are listed on Attachment B.

With the higher yielding money market accounts, Foothill Transit has allocated more to money market accounts to maximize investment opportunities while conservatively planning to meet cash flow needs.

#### **Operating and Capital Revenues and Expense Analysis** (Attachment C)

Fare revenues FY to date were up 7.95 percent compared to budget due to gradual ridership increases in the Los Angeles Region. TAP stored value usage has been gradually increasing throughout the FY as ridership experienced a similar increase. EZ Transit pass revenue was projected to decrease in FY25 due to obsolesces in LA Metro's fare structure, but the customers continued to purchase and use the pass throughout Foothill Transit services. EZ Pass revenue is 58.46 percent over budget, but 10 percent less than FY24.

Revenues for FY25 reflect application of the American Rescue Plan Additional Assistance (ARPA) federal funds. To date, Foothill Transit has spent \$25 million of the emergency federal funds on operating expenses. Also included in revenues is \$6.90 million from a funding agreement with LACMTA to provide an operating subsidy for incremental transit services on the I-10 El Monte Busway. These funds support enhanced service levels along the corridor and offset the associated operating costs.

Operating costs through June 2025, were \$149.41 million, which is \$11.39 million less than the budget and \$14.76 million more than June 2024. The variance in operating cost was attributed by the updated contract that took effect last year for the operations and maintenance of the Arcadia/Irwindale

facility. Of the \$149.41 million expenditures, \$116.86 million reflects operating costs for the Arcadia/Irwindale and Pomona operations contractors. Other operating expenses include fuel, which was \$10.69 million through June 2025.

Capital expenditures through June were \$14.17 million compared with \$15.14 million last year at this time. The annual budget for capital expenditures includes the procurement and construction of 19 zero-emission buses and security enhancements at the Arcadia-Irwindale and Pomona operations and maintenance facilities, and CNG equipment replacement at the Pomona operations and maintenance facility. Due to the need to re-procure the 19 buses originally awarded to El Dorado, Foothill Transit has awarded a contract to New Flyer and anticipates the cost of these buses will be incurred in FY 2026.

Total disbursements reflect invoices paid for the month of June 2025; they do not reflect the total expense incurred for the month. If an expense has been incurred but not yet invoiced or paid, Foothill Transit accrues the expense to track the expenses properly during the month in which they actually occurred. Total disbursements for June 2025, were \$12.59 million. Capital disbursements totaled \$0.48 million and other significant disbursements include \$3.78 million to Keolis and \$5.87 million to Transdev for bus operating services.

**Supplemental Law Enforcement Services Update** 

#### Recommendation

Receive and file the Los Angeles County Sherriff's Department Contract Supplemental Law Enforcement Services update.

#### **Analysis**

On October 25, 2024, the Executive Board authorized the Chief Executive Officer to execute a First Amendment to the existing five-year Agreement with the Los Angeles County Sheriff's Department (LASD) for Supplemental Law Enforcement Services. The amendment allowed Foothill Transit specific hours of law enforcement services to address any security or crime-related concerns that may arise. Prior to this amendment, the contract only provided "as needed" uniformed law enforcement services, which meant Foothill Transit did not contract for any specific number of deputies nor guaranteed any specific level of service. Additionally, it amended the scope of services adding "full-time" uniformed law enforcement services to "as needed" services which guaranteed Foothill Transit a minimum availability of those services.

Since the authorization from the Executive Board, a substantial amount of effort was required to finalize the amendments. Nonetheless staff and contractors worked with the Los Angeles County Sheriff's Department and communicated and planned proposed changes over Security and Emergency Preparedness Planning (SEPP) meetings.

On July 1, 2025, the First Amendment became official and two Los Angeles County Sheriff's Department Transportation Services Bureau Deputies were officially assigned to Foothill Transit, Monday – Friday from 5 A.M. to 9 P.M. Calls for service from Foothill Transit and its contractors are now received at one centralized location where Transportation Services Bureau dispatcher's direct resources from the appropriate law enforcement agency depending on day/time. Foothill Transit also has access to LASD special teams, crime analysts, and detectives who follow-through on criminal investigations. We also collaborated with LASD to track crime throughout our system using reporting districts that will assist both LASD and Foothill Transit in timely, accurate, and validated crime reporting. Foothill Transit intends to continue

hiring LASD Mental Evaluation Team members on an overtime basis to conduct 4-hour de-escalation training with contractors as that program has proven effective in decreasing bus operator assaults.

As it pertains to LASD and the recent activity of Immigration Customs Enforcement (ICE) in the region, Foothill Transit works closely with the Los Angeles County Sheriff's Department (LASD) who has clear policies and open communication to reassure immigrants they will not be targeted for their immigration status. Instead, LASD focuses on public safety and ensuring transparent communication which fosters a more cooperative relationship with immigrant communities. This approach not only enhances the effectiveness of law enforcement, but it contributes to a safer community. Both staff and contractors have been briefed on this and other related scenarios to ensure they understand Foothill Transit does NOT have an adopted policy regarding (ICE) and its agents' ability to board Foothill Transit buses to conduct checks.

Foothill Transit is a public transportation agency. ICE operates as an official federal law enforcement agency, functioning under the Department of Homeland Security (DHS) and authorized to enforce federal laws related to immigration, customs, and border control; meaning ICE agents are considered sworn federal law enforcement officers. Foothill Transit staff and its contractors who drive the buses would not be required to assist but they could not prevent ICE checks from occurring. Additionally, Foothill Transit does not collect any information related to immigration status of any of our patrons.

Overall, the first two-months of the new LASD deployment has been effective in our layered approach to overall safety and security.

#### **Budget Impact**

Funding for Amendment Number One of the LASD supplemental law enforcement services contract is included in the approved FY 2026 Business Plan – Safety and Security budget program. The current 5-year Agreement between Foothill Transit and LASD is set to expire on June 30, 2026.

Subject: San Gabriel Valley Bus Corridor Transit Improvements Project

#### Recommendation

Receive and file the San Gabriel Valley Bus Corridor Transit Improvements Project report.

#### **Analysis**

#### San Gabriel Valley Transit Feasibility Study

The San Gabriel Valley Transit Feasibility Study was launched following the Metro Board's 2020 decision to withdraw the SR-60 and Combined Alternatives from the Eastside Corridor Phase 2 Project due to environmental and engineering constraints. This decision halted plans to extend the Metro E Line further east into the San Gabriel Valley (SGV). In response, Metro committed \$635.5 million in Measure R funds to develop high-quality transit solutions for the SGV, particularly along the SR-60 corridor and adjacent communities.

Led by the San Gabriel Valley Council of Governments (SGVCOG), the study aimed to identify and prioritize short-, mid-, and long-term transit strategies that address unmet mobility needs, improve accessibility, and support regional land use and goods movement goals.

#### **Study Process and Findings**

The study was conducted in two phases:


Phase 1 evaluated 15 transit alternatives and narrowed them to seven feasible concepts based on criteria such as accessibility, equity, land use compatibility, and transit demand.

Phase 2 refined these concepts, resulting in the selection of a Hybrid East-West Concept, which combines the best-performing segments of Concepts 1 and 5. This hybrid route connects Atlantic Station (Metro E Line) to Pomona Transit Center, serving key communities and institutions such as Cal Poly Pomona and Mt. San Antonio College. The concept is projected to generate 23,400 new daily trips and received the most positive feedback during public outreach.

#### **Recommended Implementation Strategy**


The study proposes a phased implementation approach:

• Jump-Starts Projects (2028): include Near-Term improvements which would benefit existing bus services in the San Gabriel Valley. Projects could be implemented over the next three-to-five years to support the LA28 Summer Olympics. Near-Term Jump-Start projects include Traffic Signal Priority (TSP) enhancements along designated RapidBus Priority Corridors and Bus Rapid Transit (BRT) corridors and "Jump-Start" dedicated bus-only lane demonstration projects at one or more of six candidate segments.




• Mid-Term Plan (2035): Capital improvements which could be constructed beginning in 2035 with the \$635.5-million committed to the SGV by Metro Board; Mid-Term projects include additional Traffic Signal Priority (TSP) enhancements to serve new transit services including one east-west route, Dedicated BRT Corridor expansion along the proposed east-west Hybrid BRT route, Transit Center Improvements for five candidate locations, BRT shelters, 30 Emission Buses, and Bus Operations Center Improvements.




• Long-Term Vision Plan (2050): Projects and improvements that could potentially be achieved by year 2050, subject to additional funding and project development activity.

Subject: Transit Signal Priority Project Along the Line 187 and Line 188

Corridor

#### Recommendation

Receive and file the Transit Signal Priority (TSP) Project along the Line 187 and Line 188 Corridor report.

#### **Analysis**

The Transit and Intercity Rail Capital Program (TIRCP) provides funding for transformative capital improvements that will modernize California's intercity, commuter, urban rail, bus, and ferry transit systems to significantly reduce emissions of greenhouse gases, vehicle miles traveled, and congestion. This TSP project is part of a larger TICRP grant award that Foothill Transit has received.

TSP technology allows the bus to trigger the traffic signal to turn green earlier or hold the green light longer, which enables the bus to stay on schedule. TSP technology is similar to emergency vehicle signal preemption but does not grant preemption. Rules set by the jurisdiction determine the parameters under which the bus can trigger the lights when the signal is located. By keeping the bus on schedule, the customer experience improves and will make transit a better option, thus reducing single-occupant vehicles, which improves congestion and air quality. Since TSP will also keep the bus moving, there is potential to reduce travel time, which means savings in revenue hours that can be allocated to other routes to improve service reliability and frequency, adding to improving the overall customer experience on transit.

Here is an example of how the system will work: A Foothill Transit bus is running 10 minutes late and approaching an intersection with TSP installed. The system sees the bus using the bus's GPS location and also sees that the bus is running late. If the signal was red, rather than waiting 20 seconds to turn green, the signal will turn green at 8 seconds, allowing the bus to return on schedule. If the signal were already green, the signal would hold the green until the bus crossed the intersection instead of turning red. Again, to allow the bus to get back on schedule.

Foothill Transit plans to implement a cloud-based TSP system, meaning minimal work or construction on the streets. In most cases, signal controllers and firmware will need to be updated, and a cell modem will need to be installed in the signal controller cabinet at intersections. Depending on the selected TSP vendor, additional hardware may be required inside the signal controller cabinet. The TSP system must communicate with the signal controllers to trigger the green light.

Foothill Transit plans to kick off the project with a Request for Qualifications (RFQ) for project engineering in September 2025 with anticipated completion of the project in June 2027.

#### **Fiscal Impact**

The funding of the Transit Signal Priority Project Engineering and Corridor Readiness along the Line 187 and Line 188 Corridor has been included in the FY26 Capital Program.

Subject: Foothill Transit to LA Metro's A-Line Interface

#### Recommendation

Receive and file the Foothill Transit to LA Metro's A-Line Interface report.

#### **Analysis**

LA Metro's A Line, formally known as the L-Line or Gold Line, is planned to extend service to four new stations in the San Gabriel Valley. The new stations are Glendora, La Verne, San Dimas, and Pomona. An official service start date has not been announced, but operation is expected to begin late summer/early fall.

The Gold Line started operation in 2003 with service to stations between downtown Los Angeles and Sierra Madre Villa station in East Pasadena. In 2009, the Gold Line Eastside extension opened, extended the service from Union Station to East Los Angeles. Then in 2016, the Foothill Extension opened, connecting the Sierra Madre Ville station to APU/ Citrus College station in Azusa.

The first extension of the line provided service to stations in Arcadia, Monrovia, Duarte, Irwindale, Azusa Downtown, and Azusa Pacific University/Citrus College. When the Foothill Extension first opened, Foothill Transit made changes to better interface with the service. Some changes included splitting the 187 into the 187 and 188, where Line 187 traveled between the Azusa Intermodal Transit Center (AITC) and Pasadena, and Line 188 traveled between the AITC and Montclair.

This second Foothill Transit extension is opening soon which will service stops in Glendora, La Verne, San Dimas, and Pomona. Many Foothill Transit lines currently travel adjacent to most of the new stations. In anticipation of the start of the service at the new stations, Foothill Transit will introduce a new line, Line 295 which will provide service from the San Dimas station to Cal Poly Pomona and Mt. San Antonio College.



#### **Line 295- College Connector**

Line 295's northern terminus will be the San Dimas A-Line station, then travel along the 57 freeway to service Cal Poly Pomona and terminate at the Mt. SAC Transit Center. The weekday service will start at 6:00 AM and end at 7:00 PM with a twenty-minute frequency. The Planning team will watch travel time and ridership and make necessary adjustments to ensure schedule reliability and service efficiency. The team will also watch demand for service at stations and make routing adjustments as needed.
